Dismantling Disproportionality through Strategic Partnerships"



Racial disproportionality is defined as the overrepresentation of people of color in systems such as criminal justice, education, health care and child welfare. Disproportionality not only affects minority communities, it adversely affects society as a whole.

In light of the recent shooting of Michael Brown in Ferguson, Missouri, the Earl Carl Institute and its partners present a timely discussion on overrepresentation and disparate treatment of minorities in various social systems. On October 9, 2014, an esteemed group of experts in the area of Disproportionate Minority Contact (DMC) will assemble in Houston, Texas to present a forum entitled "Systemic Maltreatment: Dismantling Disproportionality through Strategic Partnerships."
